#### 1. EXECUTIVE SUMMARY

#### 1.1 INTRODUCTION

Naharkatiya College, one of the premier institutions of higher education in the easternmost part of Dibrugarh district of Assam, is situated in a sprawling greenery of tea gardens and cultivation lands. The college was established on 27th June, 1964, with the aim of providing higher education at an affordable cost to the socioeconomically backward people, mostly small scale farmers and tea garden workers of the surrounding rural and sub-urban areas. Starting as a co-educational night college with Arts stream in the premises of Naharkatia Higher Secondary and Multi-purpose School, the college has grown into a full-fledged higher education institution now with own campus spread over a plot of land measuring approximately 14.88 acres (45 bighas) and adequate infrastructure to accommodate more than one thousand students from higher secondary to undergraduate level in both Arts and Commerce streams.

The college is affiliated to Assam Higher Secondary Council for higher secondary level and Dibrugarh University for undergraduate level. The college introduced a wide range of programmes and courses through 11 departments, including a few self-sustaining ones. It has been following the Three Year Degree Course in semester system since 2011 and adopted CBCS programme as per the recommendation of the affiliating university from the year 2019. The college was recognized by the UGC under section 2(f) and 12(b) in 1978. It has gone through NAAC Assessment and Accreditation twice in 2005 and 2015 and awarded C++ and B Grade in the 1st and 2nd cycles respectively. The college is committed to create a vibrant environment by boosting participative and decentralized system by the involvement of students, teachers, alumni, guardians and local community in various perspectives and activities.

#### Vision

In consonance with the motto of the college enshrined in the college emblem "Culture alone evolves the superman" the vision of the college is to produce people of exceptional qualities by expanding the reach of qualitative education to the under privileged section of people in this remote and backward region and advancing their knowledge and skills through in campus and distance modes. The goal of the institution is to cater to the quality higher educational needs of the younger generations of this remote underdeveloped area bordering Arunachal Pradesh, the eastern most hill state of the country and to help them to acquire advance knowledge and skills for participation in the process of development of the region.

#### Mission

The mission statements of the college aim at translating the institution's vision in to action plans and define the specific tasks of the college's engagement and endeavour:

- 1. To make constant endeavour to expand the reach of quality education among the younger generations in this remote, rural and underdeveloped region of the country.
- 2. To encourage the students to acquire advanced knowledge and skills to meet the challenges of life in the age of fast technological development.
- 3. To foster the spirit of peaceful co-existence in the multicultural and multilingual social set-up by

- drawing students from different communities and ethnic groups.
- 4. To ensure the academic intellectual, cultural and physical development of the students and staff through facilitating participation in curricular and extra- curricular activities.
- 5. To stimulate the faculty members to undertake research to enhance their professional competence in the age of globalization and devise innovative methods of teaching and learning.
- 6. To collaborate with the Affiliating University in the evaluation of students' performance and quality.

### 1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

#### **Institutional Strength**

- 1. The faculty members are well educated, dedicated and the supporting staffs are also efficient and technically enabled.
- 2. Active participation of students and faculty members in various curricular, co-curricular and extracurricular activities like NSS, sports, cultural, extension work etc.
- 3. The college campus is full of greenery and regular plantation and cleanliness activities are carried out to keep the campus environment friendly.
- 4. Seminars, webinars, workshops, training programmes for students on various topics are held regularly.
- 5. The NSS unit, students' union and women study cell function actively in and around the college campus.
- 6. The college has adopted zero tolerance policy against ragging and the campus is declared as ragging free.
- 7. The college has good infrastructure for sports with a standard football / cricket play ground, volley ball complex and a well equipped gymnasium hall.
- 8. The Women Study Cell organizes programme related to health and hygiene, nutrition, gender sensitization etc. to create awareness among girls' students and women of the neighbouring areas.
- 9. The college has study centres for UG and PG courses in Open and Distance mode offered by KKHSOU and DODL of the affiliating university aiming to expand higher education for those unable to enrol in regular mode.
- 10. The college has good infrastructure like ICT enabled classrooms, seminar hall, confidential room for examination and a resourceful semi-automated modern library.
- 11. Under Industry tie up initiative, MOU with Bajaj Finserv Ltd. has been signed to organise employability skill development programmes for students.
- 12. At present there are nine active MOUs with other institutions and industries
- 13. The college Governing Body and Administration always provide full support in all activities leading to the overall development of the college.

#### **Institutional Weakness**

- 1. Lack of good quality students resulting into low progression rate to higher education.
- 2. The socio economic condition of the students (majority of which belong to tea garden labourer community) are not efficient to support their learning specially to manage the regular expenses, procuring learning materials, internet access etc.
- 3. Many of the senior faculty members lack proper training on ICT enabled mode of teaching which creates problems in effective implement of blended mode of learning.
- 4. The paucity of adequate fund and tangible resources are perennial problems as mobilisation of its own

fund is very limited. The college is funded by the UGC and the Govt. of Assam but it is not sufficient to cater to the growing needs.

- 5. Poor communication skills of students coming from rural background.
- 6. Despite the alumni being a major stake holder of the college, the financial support is still very meagre.

#### **Institutional Opportunity**

- 1. Scope for introduction of multidisciplinary and interdisciplinary courses with Arts, Science, and Commerce faculties. We already submitted a proposal to the Govt of Assam to introduce some science subjects in the college.
- 2. To continue the commitment for social service, community development through more extension activities by NSS unit and Women Study Cell.
- 3. To introduce certificate and diploma courses on computer application, make- up and beautician, weaving etc. to generate self employment by the students.
- 4. More scope of collaboration with organisations and industries for providing skill development and add on courses such as Tea Technology, Tea Tourism etc.
- 5. To tie-up with other higher education institutions both within and at interstate level for socio cultural and academic exchange.
- 6. Presently, the college has a girl's hostel with a capacity of around 50 boarders and there is provision for increasing the capacity.
- 7. To upgrade ICT infrastructure and facilities of smart class room.

#### **Institutional Challenge**

- 1. Decreasing rate of enrolment due to the growing weakness among the students and guardians as well towards town based institutions and skill based and vocational courses.
- 2. Being an affiliated college, the college has certain limitations to open new courses on its own.
- 3. Due to the rural background with low economic condition of the students at large, it is difficult to plan new self financing programmes.
- 4. The full potential of the alumni is yet to be utilised.
- 5. In the light of the NEP, 2020, although a proposal has been submitted to DHE, Govt. of Assam for opening up of a few of the trending science subjects. Otherwise it may cause problems for upgrading it to a institution offering multidisciplinary programmes.

#### 1.3 CRITERIA WISE SUMMARY

#### **Curricular Aspects**

The college prepares an academic calendar on the basis of the comprehensive academic calendar provided by the affiliating university every year. The academic departments prepare the departmental teaching plan for effective delivery of the course content. The class routine is prepared by a Routine Committee to hold the classes in a disciplined manner considering the equitable distribution of work load.

The internal evaluation of the students is carried out as per the guidelines fixed by the affiliating university. Two sessional examinations are conducted in each semester by the Examination Conducting Committee (ECC)

and group discussions and seminars are organised by the concerned departments. The departments also conduct oral tests or give assignments on its own to keep the students engaged in the learning process.

The college has been regularly entrusted with the end semester evaluation zone of affiliating university. The faculties of the college actively participate in this evaluation process. Some of the faculties are also entrusted the responsibility of paper setters of end semester examination by the affiliating university.

The college primarily provides undergraduate programs in Arts and Commerce in regular mode. Besides study centres for UG and PG programmes in open and distance mode are also available. Presently all the programs are on Choice Based Credit System (CBCS) as implemented by the affiliating university since 2019.

Being an affiliated college it has limitations to alter the curriculum fixed by the university. However the crosscutting issues like gender sensitisation, environment etc. are already integrated in the courses designed by the university. Moreover, outside curriculum the NSS unit takes up environment conservation programmes regularly and the Women Study Cell organises programs related to women welfare etc.

A few courses of the BA/B.Com programmes need project works to be carried out by the students. The evaluation of the same is done through an external examiner appointed for that purpose.

The college collects feedback from students through a structured questionnaire. Feedbacks from parents, alumni and teachers are also collected and analysed. The findings and suggestions of the stakeholders are taken into account while formulating the future plans of the institution.

#### **Teaching-learning and Evaluation**

All relevant informations about admission, institutional faculties, rules and regulations are made available through the college website and prospectus. The college ensures wide publicity and transparency in the admission process through news paper advertisement of the admission schedule. In its admission policy, the institution follows the reservation policy of the state government and in addition to the statutory reservations, 2 seats in each programme are reserved for candidates with outstanding performance in sports and cultural activities. An Admission Committee is formed to supervise the admission procedure.

The distinction between slow and advanced learners is identified through their performance in the sessional tests, class tests, seminar paper presentation, group discussion and home assignments. Personal counselling and special classes if required are arranged to improve the performance of the slow learners. For the advanced learners to develop their higher order thinking skill suggestions are provided regarding advance learning materials.

Student centric methods are applied for enhancing learning experiences. Participatory learning is always encouraged by the teachers through organising group discussions, seminars etc. A Few of the courses require field based projects preparation as a part of the experiential learning. The teachers adopt modern approach to teaching learning process by using internet, PPT presentation, field study etc. Students are also provided with academic, personal and motivational support and guidance.

The teaching learning and evaluation are organised in accordance with the academic calendar prepared by the IQAC. The marks of the internal evaluation are displayed on the respective departmental notice board to make the evaluation system transparent. The students can raise their grievances and get them resolved. Regarding

grievances related to end semester examination all sorts of assistance and guidance are provided by the college.

The college has a pool of qualified and dedicated full time and temporary teachers. 14 fulltime faculties are awarded with Ph.D degree.

To assess the satisfaction of the students, feedbacks are collected from them related to both curriculum and overall facilities available in the college. Besides alumni, guardian and teachers" feedback are also collected to improve the overall atmosphere of the college.

#### Research, Innovations and Extension

The college encourages and extends all possible help to promote research work. Reference books, free internet, reserve space for studies in the library are made available for faculty members to facilitate research works, seminars, workshop etc. Altogether 14 faculty members are Ph.D holders of which 6 were awarded the degree during the last five years. Presently 4 faculty members are pursuing Ph.D. Research papers in national and international seminars were presented by faculties. Articles in UGC listed journals, books; chapters in edited books are also contributed by the faculties.

The college undertakes extension activities in different fields like health and hygiene, blood donation, mentual hygiene, health check-up, education, awareness on commerce education, workshop on popularization of science and mathematics, environment such as plantation, swachha bharat etc.

#### **Infrastructure and Learning Resources**

Adequate infrastructure and physical facilities like classrooms, seminar rooms, library, laboratory, computer centre, sports complex etc. are available in the college for effective teaching-learning.

There are 33 classrooms well furnished with desk-benches, green boards etc. including 4 digital classrooms and two seminars cum tutorial halls with LCD projector facilities.

The college has a computer centre in the department of Information Technology, a language laboratory, a laboratory of education department and a digital laboratory. The college has 101 desktop computers and 4 laptops to support all academic and administrative activities.

The college has an auditorium with good sound system, stage, various instruments for cultural performance and other required accessories to promote cultural activities and.

The institution acquires a standard play ground for football and cricket and a volleyball complex with gallery, four rooms and office chamber for the players and officials. Rich number of sports items for football, cricket, valley ball, badminton, table tennis, arm wrestling taekwondo, athletics etc are available. Moreover the college has a gymnasium hall with modern equipments. The sports facilities are also provided to different local organisations for holding sports events.

The central library is highly enriched with text and reference books, a networking centre, news papers and journals, e-journals and periodicals. Every year latest edition of text and reference books are added to the library. Presently the central library has 44853 books and references, 15 periodicals and 7 daily news papers.

Moreover, each department has its own departmental library which facilitates the students and teachers of the respective department. The college has subscription of NLIST and INFLIBNET for e-learning. The central library is partially automated with SOUL 2.0 and KOHA software.

#### **Student Support and Progression**

The college publishes its prospectus annually where admission procedure, fee structure, library facilities, courses offered, financial support and other relevant informations are provided clearly. There are provision for institutional scholarship and free ships. The best girl graduate is awarded with an annual scholarship sponsored by Women Study Cell and two best library user awards are given every year. Scholarship is given to the SC/ST/OBC and economically weaker sections by the state government and UGC. The institution annually publishes students' magazines to nurture the creative and critical thinking ability of the students. All the departments publish departmental wall magazines. Academic counselling for admission and career counselling programmes are held regularly. Besides, the college has a Grievance Redressal Cell, Gender Sensitization and Complaint Committee for Sexual Harassment and Anti Ragging Committee to address the issues raised by the students.

The college constantly provides encouragement to the development of sports and cultural skills of the students. The Annual Sports and Cultural Week is organised every year with lots of enthusiasm where students show their talents in various events. The students also take participation in various sports and cultural activities such as Inter College Sports and Youth Festival organised by the affiliating university. Students also participate in different sports events at district, state and national level and few of them are awarded medal in the events.

Many passed out students are rendering their services at different positions in both Govt. and private organisations.

The college also organised programme on personality and soft skill development, health and hygiene, Yoga etc. for the overall development of students.

The college has an elected body of students' union with tenure of 1 year. The students' union organises various sports and cultural events and competition among the students and social service activities in nearby areas. There is provision for student representation in the IQAC core commit

The Alumni Association of the college is not registered yet, but still they always support in different academic and other activities of the college.

#### Governance, Leadership and Management

The governance of the college is aimed at decentralization and participative management. The Governing Body of the college is the highest authority for policy making and implementation. The college has an efficient internal management system for designing and implementation of its policies and plans effectively through various committee and cells constituted by the Governing Body.

Over the last five years, the college adopted e-governance in three vital areas - Administration, Finance and Accounts and Student Admission etc.

The college is managed in accordance with the Assam Non-Government College Management Rules 2001 (as amended up to date) and the Assam College Employees (provincialisation) Act, 2005. The appointment of faculties and office staff are carried out in accordance with the Assam Government Regulation released of from time to time. To meet the shortage of teachers and office staffs, the Governing Body makes temporary appointments at a consolidated pay managed from the internal resources of the college.

The performance appraisal of the faculties and librarian are carried out in accordance with the circulars issued by the Department of Higher Education, Government of Assam, which is based on the performance Based Appraisal System as notified under UGC Regulation, 2010. Depending upon the performance of the teachers and librarian, the college authority submits a confidential report at DHE, Govt. of Assam, for their promotion to next higher grade.

The Department of Higher Education, Government of Assam, UGC and RUSA are the primary suppliers of fund for smooth running of the institution. The responsibility of effective utilisation of funds and other resources is entrusted with the principal being the DDO. Several committees are formed to assist him in the process of optimum utilisation and monitoring. The utilised amounts in all aspects are also subject to audit as per the regulation of Govt. of Assam and RUSA.

The IQAC is always involved in formulation of different academic and administrative polices of the college. Many quality initiatives are taken by the IQAC like result analysis, seminars, memorial lectures, collaboration with other institutions etc. It also suggests and assists the academic departments and cells to arrange such programmes.

#### **Institutional Values and Best Practices**

Remembering the dreams and aspirations of the initiators, the college has been continuously endeavouring to deliver quality education in this rural and underdeveloped area for its academic and socio-cultural growth. The college provides an inclusive environment for all the students coming from diverse socio-economic and cultural background.

The college always promotes gender equity through providing equal opportunity and treatment to both male and female.

The non biodegradable and e-waste are accumulated and handed over to local vendors for re-cycling. The biodegradable wastes are used as natural fertilizer for the plants. The college has initiated the green campus programme through plantation and allied activities to build a sustainable and eco friendly environment.

To promote harmony and inclusive environment, the college has a fixed code of conduct for students to be followed by all irrespective of their cultural, regional, linguistic and communal diversities. The college celebrates several national and international commemorative days, events and festivals throughout the year with an aim to inculcate human values, ethics and sense of equity, integration etc. Two best practices of the college include Ram Prasad Chaliha Memorial Lecture, an annual lecture honouring the founder principal Late Ram Prasad Chaliha and Maintenance of Clean and Green Campus.

The college always tries to achieve its moto "Culture Alone Evolves-The Superman" by spreading light of education, sports and culture among the marginalised inhabitants of the locality.

Being an affiliated college, the respective guidelines regarding multiple entry and exit mechanism as formulated by Dibrugarh University will be implemented.
2. Academic bank of credits (ABC):	Being an affiliating college and a non-certifying institution the college cannot register in ABC on its own. However the ABC framework for the colleges as designed by the affiliating university in due course of time will be implemented.
3. Skill development:	a. The college is conducting several skill enhancement courses such as web design and photo shop, Travel and Tourism Management, Teaching in Elementary Level, Library and Information Sciences, Retail Management, Entrepreneurship Development etc. as a part of the regular degree course. b. The institution is planning to introduce the certificate, diploma and PGDCA courses on computer as add-oncourses in collaboration with CEC, Guwahati. c. A diploma course on beauty and self enhancement is being carried out for the girl students. d. There is a plan to introduce a diploma course on Tea Technology to meet the demand of the locality as the college is surrounded by tea gardens, tea production & packaging factories.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	a. Promoting Indian art and culture by integrating them in the main curriculum has been a primary concern of the college, as recommended by the NEP, 2020. Therefore, all curriculum and pedagogy envision in the college strongly prioritises inclusion of indigenous knowledge that is rooted in Indian tradition. b. Bilingual (English and Assamese) mode curriculum transaction is available and Hindi and Bengali are taught as MIL subjects along with Assamese and Alternative English in the UG level. c. The departments like English, Assamese, Hindi and

Bengali have been teaching all time popular classics like The Mahabharata, The Ramayana, Upanishads, and Vedas etc. d. Classical music and dance, folk song and dance, multi coloured cultural procession showcasing diverse Indian culture and heritage are significant parts in different programmes and in Annual College Week organised by the college. e. Pre Rongali Bihu has also been celebrated since the year 2022 in the month of April to inculcate the values of Assamese tradition among the students. f. Training and practice of Yoga and Meditation are conducted in the college premise under the guidance of Yoga Guru. g. The college plans to start a garden of rich medicinal plants with an aim to preserve the traditional medicinal knowledge, treatment as well as to aware the new generation about the century long tradition of India.

#### 5. Focus on Outcome based education (OBE):

a. The departments have formulated course outcomes based on the framework of the affiliating university which are displayed in the college website so that the students have academic clarity in mind. Though the course outcomes and programme outcomes are informed to the students through the students' induction programme and accessibility of prescribed syllabus, the college also arranges some co-curricular and other student engagement activities to reach the outcome more effectively. b. The departments take the initiative to organise field visits, excursion, and seminars etc.in accordance with need of the courses. c. The college has made efforts for assessing the levels of attainment of programme and course outcomes and on the basis of the findings, measures are taken for the slow learners and the advanced learners. Extra classes are taken to develop the slow learners and for advanced learners higher order skill development questions are practised regularly.

#### 6. Distance education/online education:

a. The college is offering distance education both in UG and PG levels. Presently, there are two study centres for distance education in the college. (i) Krishna Kanta Handique State Open University (KKHSOU) that offers UG programmes in Arts and Commerce and (ii) The Directorate of Open and Distance Learning, Dibrugarh University (DODL, DU) which offers the undergraduate and post graduate courses in arts and commerce. b. The college adopts ICT in classroom and uses virtual platforms for disseminating knowledge and

information to students. c. The teachers use various technological tools like online platforms, website links etc. for teaching- learning activities. During lockdown period, regular classes were conducted successfully in online mode and thereafter, blended mode was also being used.

There are 33 classrooms which are well furnished with adequate no of desksbenches, green boards and lighting facilities to make the classroom environment student friendly. The institution also posses three ICT enabled classrooms, one seminar hall and one seminar cum tutorial hall with LCD projector facilities. The college has a computer centre for the department of Information Technology, a language laboratory, a laboratory of the department of education and a computer laboratory. The college owns total 105 computers to support all the technical and academic works. The central library is highly enriched with text and reference books including encyclopedias. It has about 140 seating capacity for students and teachers. Every year latest edition of text and reference books are added to the Library. A Network Resource Centre with 7 computers is attached with the library where students surf the internet for electronic resources. Besides, the library is partially automated with KOHA software. The college owns an auditorium with good sound system, stage, sitting capacity and other required accessories to promote cultural activities and various instruments for cultural performance. The institution maintains a play ground well protected with boundary walls. A volleyball complex with gallery for 500 spectators with four rooms and one office room for physical instructor is available. The play ground and volleyball complex are maintained with internal resources of the college and sports competitions are held in the play ground. The play grounds including the volleyball complex are provided to different local organizations for holding sports events. The college acquires a well equipped gymnasium hall with two multi station gym, treadmill, cycling pad, iron barbell set, dumbbell sets etc. Moreover, it has a rich number of sports equipments such for cricket, football, volleyball, badminton, table tennis, athletics accessories, arm wrestling etc. The college has also installed two environment friendly generators for power backup.

The library is running with open access facilities that help easy access to the users. The library has total 44853 books including text and reference books, 7 daily newspapers, 15 numbers of thesis etc. The library has access to NList consortium provided by INFLIBNET Centre, Gandhinagar, Gujrat, for e-books and e-journals. The library is partially automated with KOHA, a cloud based open source library management software for creating books and members' database and is being regularly updated. Two separate computers are provided to the library users for searching the books on Online Public Access Catalogue (OPAC). The library has provided in campus Institutional Repository Service using a dedicated server with Dspace open source software. Name of ILMS software – KOHA Nature of automation (partially), Year of Automation – 2015 (SOUL) and 2020 (KOHA). The library has subscription for good number of Journals of different disciplines and also E-Shodhsindhu. The library is regularly used by both the

#### 6.1.1

The institutional governance and leadership are in accordance with the vision and mission of the Institution and it is visible in various institutional practices such as NEP implementation, sustained institutional growth, decentralization, participation in the institutional governance and in their short term and long term Institutional Perspective Plan.

#### **Response:**

Naharkatiya College, situated near Joypur, is a rural college, surrounded by forests and paddy fields. The people living in this area are mostly farmers, small entrepreneurs, office job holders and daily wage earners. Naharkatiya College is the only institution of higher education, imparting the light of knowledge in this economically backward region. So the aim of this institution, from its very inception, is to provide the students of the locality the opportunity of a better life through education as well as uplifting the sociocultural atmosphere of the region. Besides, it also aims to impart universal human values and ethics which are very well reflected in its motto, inscribed on the main entrance gate: "Culture Alone Evolves"-The Superman. Keeping in mind its priority, Naharkatiya College, always encourages the local students to enroll in to the institution by not strictly adhering to a cut-off mark. In addition to classroom teaching, students are encouraged to take part in seminar presentation, group discussions and project preparation which urges them to acquire in-depth knowledge on relevant topics. The college ensures all round development of the students by organizing cultural, literary and sports activities and encourages students to participate in such activities at Local, District, State and National level. The college undertakes different extension activities through NSS, Women Study Cell, and other Government and Nongovernment organizations. The IQAC takes feedback from different stakeholders and their suggestions are taken into consideration while taking financial and academic decisions. Department of Higher Education (DHE), Government of Assam is the supreme administrative authority of the college. However, the Governing Body is vested with sufficient authority and power at institutional level to implement the plans and policies of the department. This committee comprises of a governmentappointed President, two university nominees, principal as secretary, two teachers' representatives, two guardian representatives, librarian, one donor member and a member from the office staff. The principal is selected on the recommendation of a committee headed by the Vice- Chancellor of the affiliating university and the appointment is made by DHE, Assam. The principal is responsible for implementing the orders and decisions of DHE and Governing Body. The college has a clearly defined organizational structure for decentralization and participative management. Participation of the teachers and students in decision making and working bodies of the college contribute to transparent governance. Various bodies like IQAC, Routine preparation committee, Construction Committee, NSS, Admission Committee, Antiragging committee, Examination Committee, Women's Study Cell, Sexual Harassment Committee, Library Committee, RUSA Project Monitoring Unit, Students' Union etc. take part in the decision making process. The Principal of the College holds regular meetings with the teaching and non-teaching staff and students' union.

The college deploys strategic plan regarding the following aspects: The departments prepare their respective teaching plans and the departmental heads distribute the work load among the teachers. The teachers chalk out their own plan of teaching strategies. The college prepares an academic calendar based on the comprehensive academic calendar of the affiliating university. The students are encouraged to take part in various co[1]curricular and extra-curricular activities for all round development. The college follows the semester system of examination of the affiliating university .Students are evaluated through a combination of external (80%) and internal assessments (20%). The faculties are always encouraged by the top authority to engage themselves for both micro and macro level research works like, MRP and PHD etc. There is a partially automated central library with rich collection of text and reference volumes, a reading room of 140 seating capacity, a Network Resource Centre. The college takes steps to appoint staffs whenever there is a shortage of teaching and non teaching staff for smooth functioning of the teaching learning process and office works. Department of Higher Education, Government of Assam has the responsibility to frame the policies for smooth running of Higher Educational Institutions in the state. The college is managed in accordance with the Assam Non Government College Management Rules 2001 (as amended up to date) and the Assam College Employees (Provincialisation) Act 2005. Under these rules no authority/ power is vested in the top management to bring about any organizational change. The Governing Body is the top management body of the college and the Principal executes the decisions of the body. The Heads of academic departments ensure that the plans communicated to them by the Principal are implemented systematically. The appointments of faculties and office staff are carried out in accordance with the Assam Government Regulations released from time to time. The service records of the faculty members and office staff are maintained and recorded on the service books by the college authority as per the Govt. guidelines.

The performance appraisal of the faculties and librarian are carried out as per the circulars issued by the Department of Higher Education (DHE), Government of Assam (GoA), which is based on the Performance Based Appraisal System as notified under UGC Regulation, 2010. The minimum API scores under different categories are considered for promotion of teachers and librarian to the higher grades. The teachers and librarian are required to submit the details of the academic and professional development activities, viz. Induction programmes, Refresher courses, workshops, publication of research papers and articles, participation in seminars etc every year to the IQAC. The involvement of the teachers and librarian in co-curricular and extra-curricular activities is also taken into consideration as part of the performance appraisal. Depending upon the performance of the teachers and librarian, the college authority submits a confidential report to DHE, GoA for promotion to next higher grade. It is reflected in increase in number of faculties having PhD and also presently registered

### 6.4 Financial Management and Resource Mobilization

#### 6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/nongovernment organizations) and it conducts financial audits regularly (internal and external)

#### **Response:**

The funds are primarily received from the Department of Higher Education, Govt. of Assam as well as from RUSA for smooth running of the institution. The Finance Department, Govt. of Assam sanctions the amount required for salary on the basis of the budget submitted by the college for a given financial year. DHE, Govt. of Assam releases certain funds for academic and infrastructure augmentation to the college from time to time. The college prepares an annual budget comprising of different heads of expenditure. Though the primary responsibility for optimum utilization of the fund is entrusted with the Principal (DDO) yet various committees are formed to look after the proper utilization of fund and to assist him. The utilization of funds is subject to audit by the government. A portion of fee collected from the students is expended for maintenance of academic and physical facilities. A fund for the Library is also created to meet the expenses of the library. These funds are utilized for the benefit of students and for meeting other expenses of the college. The auditor appointed by the Govt. of Assam as per Assam

Financial Rules, conducts the external audit. They verify and confirm all finance related items. The audit report and utilisation certificates are submitted to the finance department, Govt. of Assam as well as the concerned funding agencies like RUSA. The audit reports are also preserved in the college for records. All the vouchers related to the expenditure, updated copy of Bank passbook and all other necessary supporting documents are submitted to the auditor as and when asked for verification and settling any audit objections.
